Children turning 13 before January 1, 2012 are required to purchase an Adult Season Pass (birth certificate required). Anytime Season Pass good day and night with no restrictions during the 2011/2012 season. Benefits include: Hands-Free Lift Access, Guaranteed Admittance during Sellout Periods and 10% Off Non-Sale Retail Items. and \$10⁰⁰ Off Ski and Snowboard Lessons.

_____ **Free Child Season Pass:** Child (ages 6 & under). Limit two (2) Free Child Season Passes per Adult Season Pass purchased. Children turning 7 before Jan. 1, 2012 are required to purchase a Child Season Pass (Birth Certificate req.). Anytime Season Pass good day and night with no restrictions during the 2011/2012 season. Benefits include: Hands-Free Lift Access, and Admittance during Sellout Periods and 10% Off Non-Sale Retail Items and \$10⁰⁰ off Ski/Snowboard Lessons
